Introduction

Moloni regularly communicates content, either created in-house or by third parties, on topics related to business activities and entrepreneurship. The content is formatted and made available via a newsletter, which can be subscribed to either through the Moloni account subscription process or via direct registration, both accessible through the official Moloni ON website at www.molonion.pt.

Data controller

The personal data collected and processed for the purpose of sending newsletters is managed by Moloni Unipessoal, Lda., headquartered at Av. What personal data do we collect?

Through the Moloni ON newsletter subscription channels, we only request an email address, which will be used to send communications.

Purpose and lawfulness of processing

The collection and processing of the email address serve the sole purpose of sending newsletters. This processing is based on the data subject's consent, which may be withdrawn at any time via the "unsubscribe" links provided in the communications or by an explicit request via email to the platform's support services.

How do we use the information you provide?

Through the emails we send, we also collect information about your interaction and engagement with the newsletter, such as whether you have viewed it, clicked on any links within it, or the IP address used to do so.

This data is collected using cookies and other tracking technologies to assess your interest in the topics covered in our emails and your interaction with the content we create for our users. We use these tools to continuously optimise the content we deliver to you.

Who are the recipients of the collected data?

The collected data is accessed and processed by Moloni's Communication & Marketing team, as they are responsible for interpreting the data to refine the messages produced and presented to Moloni ON users and interested parties. Additionally, Moloni has chosen the Brevo platform - <https://www.brevo.com/landing/email-marketing-service> to manage email addresses for communications, as well as subscription-related data and subscription management. This platform has no rights of use over your personal data, nor does it use it to send you marketing information other than that related to Moloni ON.

Data retention period

You can subscribe to the newsletter via the official Moloni ON website or during the platform subscription process. You may unsubscribe at any time by clicking the "Unsubscribe" link provided in the footer of all newsletters we send. If needed, you can also request removal by emailing apoio@molonion.pt.

Once you unsubscribe from the newsletter, you will no longer receive our emails. If you wish to receive them again, you will need to register again through the available subscription channels.

If the email address used for the Moloni ON newsletter subscription is the same as the one linked to your invoicing service subscription, it will only be used for newsletter-related tasks to cross-check against addresses that have requested removal.
